Enclosed is a minor permit modification to Solid Waste Permit No. 101389 for the operation of Frey Farm Landfill, issued in accordance with Article V of the Solid Waste Management Act, 35 P.S. §§ 6018.101, et seq.

This permit modification approves the implementation of a visual landscape synthesis plan, including the planting of trees and shrubs, along with allowing for natural succession, on the final cap of the Frey Farm Landfill.

Compliance with the terms and conditions set forth in the permit is mandatory. You have the right to file an appeal as to these terms and conditions.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board) pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S.A. Chapter 5A. The Board's address is:

## PERMIT CONDITIONS:

- 1. The Visual Landscape Synthesis Plan ("Plan") was required to be submitted by permit condition #6 of the July 26, 2017, Major Permit Modification approving the Frey Farm Vertical Expansion and Increase in Daily Volume. The effective implementation of the Plan serves to reduce the visual aesthetic impact of the Frey Farm Vertical Expansion, as identified in the Environmental Assessment review of the permit application and included in the Harms/Benefit Analysis for the Frey Farm Vertical Expansion and Increase in Daily Volume.
- 2. LCSWMA shall submit to the Department, along with the Annual Operation Report, a report describing the status, progress and effectiveness of the Plan in achieving the Plan objectives. The annual report shall, at a minimum, include the following information:
  - a. A summary of the implementation activities that occurred during the prior year, including identifying the numbers and types of trees planted in relationship to the Plan, the area(s) where plantings occurred, and which Stage of the Plan was implemented during that year;
  - b. Representative photographs of the areas where the Plan was implemented during the prior year;
  - c. A description of the maintenance that occurred during the prior year and if there were any significant problems or concerns with the implementation of the Plan;
  - d. A description of any proposed modifications or revisions to the Plan based upon data gathered in the field; and
  - e. A summary of anticipated implementation activities for the next year and any modification to the schedule. The Department will determine if a permit modification is necessary to incorporate any additional modifications or revisions to further enhance the effectiveness of the Plan.
- 3. Any final operation, design, or other plan developed subsequent to permit issuance which exhibits changes in the structures, locations, specifications, control measures or other changes of substance shall be submitted to the Department for subsequent permit action. Any deviation of plans herein approved shall not be implemented before first obtaining a permit modification or written approval from the Department.
- 4. Nothing herein shall be construed to supersede, amend or authorize violation of the provisions of any valid and applicable local law ordinance, or regulation, provided that said local law, ordinance or regulation is not preempted by the Pennsylvania Solid Waste Management Act, the Act of July 7, 1980, Act 97, 35 P.S. §§ 6018.101, et seq.
