Opening

With Chairperson Brubaker joining remotely, Vice-Chairperson Rettew led the meeting and opened with a requested moment of silence followed by the pledge to the flag.

Approval of Minutes

Action Items

1. BOARD ACTION NO. 1: APPROVAL OF MINUTES OF JULY 22, 2022

Vice-Chairperson Rettew asked for any additions or corrections to the meeting minutes. Being none, a motion was requested to approve the Minutes of July 22, 2022, as distributed.

Chief Executive Officer

Mr. Zorbaugh introduced the Executive Team reports with good news of the robust month of July performance continuing into August.

Mr. Zorbaugh directed the focus to two items dealing with Community Outreach, first recognizing Karen Gross for her outstanding efforts in developing additional partnerships in Dauphin County by supporting their community clean-up initiatives. Mr. Zorbaugh described community outreach efforts, including tarp enforcement with enhanced education efforts through multiple media outlets. Enforcement includes a \$20 penalty imposed to encourage compliance. LCSWMA is considering donating the penalty fees back into the community to fund litter clean-up efforts, clean-up of waterways and illegal dump sites. To wrap up this topic, Mr. Zorbaugh answered questions regarding disposal of tires.

Next, Mr. Zorbaugh provided forward-thinking focus on future landfill capacity planning, one of the Executive Team's 2022 goals. Mr. Zorbaugh presented several options suitable to manage waste capacity in the long term, including purchasing a greenfield site in Lancaster County to develop into a new landfill, purchasing a greenfield site outside Lancaster County, reuse of the existing Creswell landfill, contracting with a third party for landfill disposal outside of the Lancaster County region, or a combination of these

options. The presentation included the Department of Environmental Protection's criteria for development of greenfield sites, landfill capacity information for the Frey Farm Landfill, the concept of reusing the Creswell Landfill, and data on area disposal facilities. Mr. Zorbaugh deferred to Mr. Adams for clarity and concerns regarding current landfill capacity for all the regional sites. Mr. Zorbaugh and the Executive Team fielded questions on each of the options presented.

Chief Financial Officer

Mr. Youngs opened with further details on budget and revenue, including a decrease in ferrous markets offset by above budget operations revenue. Mr. Youngs affirmed rising inflation and global supply chain disruptions contributed to operating expenses which exceeded budget, pointing to diesel as a significantly elevated cost line, although retreating from recent highs, but emphasizing that costs were absorbed.

Mr. Youngs went on to provide specifics on trending record-high revenue and high watermark EBITA for LCSWMA but stressed the need to maintain a conservative approach with long term planning for the organization. While Mr. Youngs acknowledged great team performance, he expressed that these margins of performance are necessary within the organization to ensure reserves are adequate to support long term needs. Staff continually evaluate and update projects for long-term system planning, spanning over a 20-year horizon. In addition, Mr. Youngs brought up forthcoming rate discussions, the details of which to be furnished by Mr. Adams later in this meeting.

Next, Mr. Youngs provided highlights on IT initiatives, including the deployment of new systems to be fully in place by the end of September to mitigate risk, and a multi-year endeavor on file organization structure and document retention.

After fielding questions, Mr. Youngs introduced two action items for Board consideration and approval.

Ms. Marsh briefly touched on pending regulatory changes, specifically RACT III (Reasonable Available Control Technology) to provide awareness on the impacts to the Lancaster WTE Facility. A new limit of 110 ppm was approved for Municipal Waste Combustors in PA and is set to become effective January 1, 2023. Ms. Marsh noted LCSWMA and Covanta are evaluating options for the Lancaster WTE Facility, including installation of Low NOx technology.

Next, Ms. Marsh introduced two items for Board consideration and approval, the first item being a resolution regarding purchase of certain Turkey Hill properties on River Road near the Frey Farm Landfill.

Board Action No. 3

ISSUE: Susquehanna Resource Management Complex (SRMC) Çamera System Replacement

BACKGROUND: LCSWMA facilities are equipped with various technology inclusive of on-premise camera surveillance to monitor site safety, security and operations. Camera surveillance provides managers the ability to monitor site operations and traffic flow. These systems prove valuable during times of debate on claims or incidents while also providing means for coaching employees on best practices for safety and equipment operation. The SRMC facility utilizes 30 cameras, video storage and playback functionality.

DISCUSSION: Staff obtained pricing through the PA COSTARS purchasing program. Triangle Communications, a reputable Lancaster County organization, provided the lowest cost replacement quote using an Avigilon system inclusive of system hardware (60-day storage), upgrading nine cameras to wider view hi-resolution cameras (eliminate 3 existing cameras, improved coverage with less hardware), two new cameras at new locations, switches, cabling and installation. Avigilon systems are also deployed at the TSC & WTE. This replacement is due to the camera system being at end of life (nine years old). The life expectancy of the Avigilon system is eight to ten years. This camera replacement was budgeted for 2022 at \$40,000. Pricing has been impacted by semiconductor shortages, materials and shipping costs, technician wages, and enhanced scope.

Board Action No. 6

ISSUE: Purchase of Equipment for 2023 Delivery

BACKGROUND:

LCSWMA utilizes a cyclical equipment replacement schedule, with replacement frequency based on utilization rate, maintenance costs, and residual value of each type of equipment. In the past, staff has presented the following fiscal year budget and capital expenditures plan (including equipment) at the October Board of Directors' meeting, with Board action on the budget at the November meeting. Specific purchases were then brought to the Board for consideration any time thereafter.

DISCUSION:

Due to the long lead time from order to receipt for most of the equipment LCSWMA procures, staff would like to begin ordering 2023 replacement equipment. Lead times for the equipment listed below are in excess of one year. LCSWMA uses cooperative bidding and purchasing contracts when available to procure new equipment to minimize cost. The chart below details the site, type and model, cost, estimated trade-in or auction value, net cost, 10-year capital plan amount, variance to this amount, and purchasing contract for each piece of equipment. The 10-year capital plan amount was developed in July 2021 and there has since been upward price movement for most equipment. This is the first of several batch purchases of equipment for 2023.

Board Action No. 7

ISSUE: Change Order No. 1 to ARM Group for the Frey Farm Landfill Vertical Expansion (FFVE) Stage 2 Construction Quality Assurance Testing and Inspection Services

BACKGROUND: A contract was awarded at the May 21, 2021, Board of Directors meeting to ARM Group for the FFVE Stage 2 Construction Quality Assurance (CQA) Testing and Inspection Services. The FFVE Stage 2 Construction Project will increase the capacity of the Frey Farm Landfill with the construction of an MSE Berm and approximately 3.5 acres of additional liner. Per Pennsylvania Department of Environmental Protection requirements, all landfill construction projects require engineering oversight, inspection, and testing to ensure they are constructed in accordance with all rules and regulations. Due to the size and complexity of a project such as the FFVE Stage 2 construction project an experienced third-party engineering and consulting firm is utilized for these services. The original contract price was \$396,842.

DISCUSSION: The original scope and cost of the Construction Quality Assurance (CQA) Testing and Inspection Services was estimated based on experience with similar projects as well as expected project schedules. Based on the actual FFVE Stage 2 construction schedule and changes to ARM's scope of work, additional expense was incurred for CQA Testing and Inspections Services. Change Order No. 1 will increase ARM Group's contract by \$65,250 to cover the additional expense of CQA Testing and Inspection Services.

WHEREAS, LCSWMA has determined that it is appropriate to authorize the purchase by deed in lieu of condemnation from TH Real Estate Holdings, LLC four separate tracts of real estate located in Manor Township, Lancaster County, Pennsylvania, known as 2580, 2602, 2620, and 2617 River Road (the "Properties"), as more fully described in the Agreement of Sale (the "Agreement") which is attached to and made a part of this Resolution as Exhibit "A";

BE IT FURTHER RESOLVED, by the Board that the CEO is authorized and directed to take all other actions which are necessary or appropriate in accordance with the Agreement, including, but not limited to, execution and fulfillment on behalf of LCSWMA of the Agreement of Sale for Real Estate attached hereto as Exhibit "A", and any amendments thereto, in substantially the same form presented at this meeting, with such changes as the CEO shall deem appropriate and in the interests of LCSWMA, including but not limited to reductions in the purchase price as a result of the inspection reports, and all actions taken by the CEO in connection with the acquisition of the Properties, including but not limited to the obtaining appraisals and inspection reports, execution of the Agreement, payments as set forth in the Agreement, the Deed and all closing documents, are hereby ratified, authorized and approved; and
