Enclosed is a minor permit modification to Solid Waste Permit No. 101389 for the operation of Frey Farm Landfill, issued in accordance with Article V of the Solid Waste Management Act, 35 P.S. Sections 6018.101, et seq.

This permit modification approves the Frey Farm Landfill to allow Blue Phoenix Inashco to age ash stockpiles inside the permitted limit of waste on the Frey Farm Landfill to improve the ferrous and non-ferrous recovery.

Compliance with the terms and conditions set forth in the permit is mandatory. Please note that issuance of this permit does not eliminate the necessity to comply with all federal, state, or local requirements at the permitted facility. You have the right to file an appeal as to these terms and conditions.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board) pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S.A. Chapter 5A. The Board's address is:

PERMIT CONDITIONS:

- 1. Any final operation, design, or other plan developed subsequent to permit issuance which exhibits changes in the structure, locations, specifications, control measures, or other changes of substance shall be submitted to the Department for subsequent permit action. Any deviation of plans herein approved shall not be implemented before first obtaining a permit modification or written approval from the Department.
- 2. Nothing herein shall be construed to supersede, amend or authorize violation of the provisions of any valid and applicable local law ordinance, or regulation, provided that said local law, ordinance or regulation is not preempted by the Pennsylvania Solid Waste Management Act, the Act of July 7, 1980, Act 97, 35 P.S. § 6018.101, et seq.
